# Public Open Space on Barrisdale

**Tabled Public Submissions Report** 

3 June 2022



Engaging with our diverse community to achieve an inclusive, vibrant and sustainable future.

#### Information

The City has developed a draft concept design for the new Public Open Space on Barrisdale Road, Ardross.

The draft design features new park furniture, informal nature play space, exercise and mobility equipment, outdoor games, additional planting and more.

Consultation took place 26 April - 22 May 2022. During the consultation period, community were invited to view the draft concept design and provide level of support.

Feedback received will inform the final concept design.

## **Engagement Reach**

To bring awareness to the project and the opportunity to provide comment, respondents were informed through a number of digital and traditional communication channels. This included a direct invitation via email and letter to residents, ratepayers and stakeholders 400m radius from the location, a dedicated Melville Talks webpage, on-site signage, social media post and eNews publication article.



## **Engagement Outcomes**

114 submissions were received, with 83.3% providing overall support of the Strategy.

- 53.51% support
- 29.82% support with concerns
- 13.16% do not support
- 3.51% did not provide a level of support

## Key themes for level of support

### Positive (most liked)

- Good use of a space currently providing little public benefit
- Establishment of a green space usable by the community
- Delivers mobility exercise area for seniors and play options for kids
- Nature-friendly design includes trees, shade and seating
- Complements adjacent bowling facilities, adding to family options
- Beautifies the neighbourhood and benefits local community spirit

### **Negative (community concerns)**

- Lacks a basketball / netball court and fitness equipment
- Needs to include more play equipment for kids
- Requires shady trees and shade sails
- Nearby parking bays, lack of traffic calming and closure of Barrisdale Road entrance creates safe access concerns
- More grassed areas not seen delivering local benefit
