Home Business Further Information:

Please see below points for further information of the proposed home business application for the new extension.

The nature of the business

The business name is Flower Nation. ABN ABN 30 592 331 538. Sole Trader small business operated by myself. The proposed work will be floral design/ floristry for wedding and events. This involves making arrangements and bouquets for wedding clients or centrepieces for functions. These are about 20-25 events per year with no retail operation at all. The work will be carried out in a workshop space behind new garage extension and will not be visible to street or neighbours. The work is quiet of nature not involving any loud noise etc.

In addition to the fresh flower work carried out in studio space in garage as per existing conditions, the business had evolved in 2020 to include dried flower design and teaching workshops as a response to challenging business conditions in the event industry.

As per emails to Gavin some workshops have been hosted onsite (less then 24hours total per annum) and I am planning to increase this side of the business in 2021 and future.

The workshops are being hosted in the second story extention space marked "Activity" which has been set up as a dried flower workshop to accommodate 6 to 8 attendees.

The fresh flowers and dried flower areas are NEVER used at the same time.

The proposed days/hours of operation

Most of the work is late week- weekends as that's the nature of the wedding industry, so usually from Thurs afternoon- Saturday.

The workshops are usually held either school hours weekdays for 1.5-2hours, or on a weekend run time 1.5-3hours.

The number of clients/customers/courirs/

No clients/customers as it does not involve any retail operation at all. Couriers for flower/sundry delivery may be in the driveway for a short time(30 min max) to unload goods Wed-Fridays.

The attendees will be onsite are limited to 8 people (sometimes if it's a kids workshop (legal guardians will also attend the premises).

Some clients may attend to collect items.

Proposed signage

Most likely no sign at all, potentially a very small sign not exceeding 0.2sqm on garage next to garage doors in future.

Sign to be installed not exceeding 0.2sqm on garage wall

The number of employees proposed

For most events only the homeowner, some casual helpers may be brought in for large events not exceeding 2 people.


A site plan of the property


