

Form 4 Local Government Act 1995 Local Government (Administration) Regulations 1996

## Register of Gifts and Contributions to Travel January 2016 to 31 July 2019

As of Friday 4 March 2016, the Local Government Act 1995 requires a relevant person who accepts a gift worth more than \$200.00 to disclose this gift, in writing, to the Chief Executive officer within 10 days of receipt. The Chief Executive Officer is required to keep a record of the disclosures by way of a register.

All contributions to travel over \$200.00 must also be disclosed as do multiple gifts or contributions from the same donor where the total value is over \$200.00 A relevant person is defined under section 5.74 of the Act as a person who is a Council member or a designated employee which includes:

- Mayors
- Presidents
- Council Members
- The Chief Executive Officer
- Employees with delegated powers or duties under Part 5, Division 4 of the Act;
- Employees who are members of committees comprising elected members and employees; and
- Other employees as nominated by the local government to be a designated employee.
