

Notice of Intention to Levy Differential Rates 2025-2026

Tabled Public Submission Report June 2025



Executive summary

Each year, the City issues a Notice of Intention to Levy Differential Rates as required under Section 6.36 of the *Local Government Act 1995*. This notice is supported by a statement outlining the objects and reasons for adopting differential rates across various categories of property within the City.

As part of the 2025–2026 Annual Budget process, public consultation on the proposed differential rates was conducted from 21 May to 12 June 2025. During this period, electors and ratepayers were invited to provide feedback on the proposal. Submissions were accepted via the City's website (www.melvillecity.com.au/differentialrates), as well as through alternative methods including written submissions, telephone, inperson feedback, and hard copy forms.

While the legislative requirement is for a minimum 21-day advertising period, the City extended the consultation to 23 days to maximise community participation. The consultation was widely promoted through both traditional and digital communication channels.

A total of 449 valid submissions were received. Respondents were asked to indicate whether they supported, objected to, or neither supported nor objected to the proposed rates.

This report provides a summary of the feedback received, including an overview of overall community sentiment and levels of support by suburb, and tables all comments for Council's consideration.

Engagement findings

449 submissions were received, with 97.8% expressing objection to the Notice of Intention to Levy Differential Rates.

Participant demographics

To ensure the engagement/public comment process reflects the City's diverse community, submitters were asked to share their demographic information.

• 99.11% of submissions received indicated they resided within the City of Melville.

Analysis of submission content

Submissions were reviewed to identify key themes and concerns raised by community members. The analysis reveals a predominantly negative sentiment toward the proposed rate increase, with several recurring issues consistently highlighted across responses.

Sentiment overview

The overall sentiment across submissions was predominantly negative, with most respondents either objecting to the proposed increase or expressing frustration at the lack of justification or perceived value. A small number of submissions offered neutral or constructive feedback, and a limited number expressed support for the proposed changes.

Tabled comments

A total of 461 submissions were received, with 12 identified as duplicates. These were merged and counted once to ensure data accuracy, leaving 449 submissions for consideration.

The following comments are presented as submitted, with identifiable personal information replaced with [removed].

During the review, several submissions contained repeated or highly similar wording. Further investigation, including contact with some respondents, confirmed that a social media post on an external platform had circulated example wording for community use. Some submissions were also completed by multiple members of the same household, such as a husband and wife, using similar content. These were treated as separate submissions, as they were lodged by different individuals.

1	Object	Please justify the increase. What factors have contributed to this rise and why? What savings is the city making to reduce costs?
2	Object	As a ratepayer and owner of two homes in the City of Melville, I find it incredulous that the City would propose such a steep increase in rates without providing adequate rationale and a supplementary proposal for the additional funds' use. I'm also deeply concerned that the City of Melville is not taking residents' concerns of safety and security seriously and addressing the crime problem with said funds (or at least not communicating any plans to do so).
3	Object	[Address removed]. As a corner block, majority of the land belongs to the Council. However, the Council does not maintain the land. In addition to the rates, I have exorbitant amount of water usage and mowing and maintenance cost to pay. I will appreciate if the Council will look into this and see if you give me some form of compensation for maintaining your property. I have lived here since mid 1995. Thank you. Regards, [name removed]
4	Object	For residential rates, I am objecting to the stated increase in rates when it is almost double the CPI (currently sitting at 2.4%) with no justification. I have no issue with commercial increases, but residents shouldn't be responsible for making up a budget deficit if the City has failed to appropriately fiscally plan.
5	Object	The rate does not reflect dwelling density and boxed in properties that have differential quality of life. Recent zoning changes and electoral outcomes are going reduce quality of life. Subcategorisation is essential for both property types to equity based sqm rates.
6	Object	Why are rates going up faster than inflation? What about reducing rates as the dwelling density increased in my area? Just doesn't make sense.

7	Object	Hello. We are struggling to live pay check to pay check. You will place more pressure on our shoulders. If anything, please reduce our rates. Or find ways to tighten your belts to not have to pass on the cost to us. Thank you. [name removed]
8	Object	When will the elected representatives in our local state and Federal governments finally realise that you cant endlessly raise taxes and rates? When will anyone actually, for just one year, reduce spending?? You are driving the community into the ground and should all be ashamed. I know you think you are doing the right thing but you are wrong. Reduce spending and fund cost of living reductions. Its not that hard. Pretend its your money.
9	Object	All unimproved land should have zero rates! The council does not provide any services to unimproved land. If an owner of unimproved land lodges a building application this should be done on a fee basis. Rates should be charged at commencement of building.
10	Object	Rates should be frozen given the current (and sustained) cost of living crisis and the impact it is having on many City of Melville ratepayers. It would also be of use if the city can better explain, and breakdown the reason(s) for increasing the Residential Improved/ Unimproved Land rate in the dollar. The City of Melville already has some of the highest rates in the state.
11	Support	We are family of 4 and I feel I'm paying too much in council rates for my property. In this current situation it is very hard for young family to survive and raise 2 children. To top it have a huge mortgage to pay. Appreciate Council considers my plea and do their best to my request and give some consideration.
12	Object	The rise is significant and above CPI. Consideration needs to be given to reducing spending!
13	Neither support or object	Cost living is high and we need to adjust the levy to link to the services, currently we are not getting better services from the council.
14	Neither support or object	As a resident with dependent children, we use few city resources but face daily safety concerns due to poor footpaths and inadequate street lighting in our area. Before supporting the proposed rates, I would like to understand how this budget will improve local infrastructure and better distribute funds to under-served residential areas. Transparency and equity should guide the city's priorities in allocating rates.
15	Neither support or object	This proposed 4.5% increase is a joke. The council does not have to increase rates at all. Has it ever thought about tightening its belt rather than continuing with a mindset to spend more and more every year? Remember, you are servants of the ratepayers of the City of Melville. So, at this time of the year, think more about cutting back not spending more.
16	Object	My objection is very simple. As As a retiree, there is no way the my income has gone up by 4.5% this financial year. I can't see a noticeable improvement in the services provided. So why should my rates automatically increase?

17	Object	I Strongly Object to the 4.5% increase in rate payments. The Federal Government is responsible for the increase in the cost of living and inflation so why should the tax payer / rate payer have to pay the extra costs for increase in
		materials and labour to maintain the Melville area. The Federal Government should be "picking this up" Full Stop!
18	Object	What is the justification for a 4.5% revenue increase, which is significantly greater than the CPI increase?
19	Object	Local Government Act 1995, Section 6.32 "When adopting the annual budget, a local government — a) in order to make up the budget deficiency,etc" Information does not indicate a budget deficit, the application of differential increase of 4.5%. I do object to a rate increase without adequate identification of exactly what the deficit is, if there is no deficit a differential rate increase cannot be included in the budget.
20	Support	I acknowledge the increasing costs of delivering services. I support increases that relate to the core business of the council including increases in wages for essential staff. I do not support increases for wages for non-essential management or any addition of management roles that are not core to the role of the council. I suggest that non-improved residential land that does not have any applications in to build on has a rate-based penalty applied.
21	Object	With all the cost of living pressures/increases currently this would just be more financial stress.
22	Object	This is more than wage increases given to most in one year, more than the current CPI, more than the current interest rate. The increase is too much given the current economic climate and many (including me) will not be able to afford it.
23	Object	I object to the 4.5% increase in rates Times are tough and a lot of people and families are struggling
24	Object	I believe in today's environment that this levy increase is way beyond the current CPI, most people's wage inreases, more than the current interest rates. How is one meant to survive if you keep pushing things up like this when we're struggling to feed and cloth our kids and ourselves. [Attached more information] Times are tough and if it keeps going we might just become another homeless statistic cos we can't keep affording these costs of living going up more than the CPI and our take home pay. Please reconsider this figure as it's just causing more stress on us than the stress we're already feeling.
25	Neither support or object	Please allow weekly rubbish collections, this fortnightly collection is ridiculous
26	Object	Whilst the cost of everything is going up it's extremely hard to support an increase nearly twice the level of inflation.
27	Object	I don't see the council requirement to increased rates whilst everyone is struggling to meet current cost of living. Austerity measures need to be inplaced, project evaluation needs to be tightened. Big business is doing it, the council needs to also.
28	Object	A rate increase of more than wage increase is unaffordable to many. Can't afford, please stop spending \$ including champagne lunches.

29	Object	I would first look at the salary of senior City of Melville staff - ie, CEO as a way to reduce costs. Also look at areas
		to save costs including waste management and other areas of efficiency.
30	Object	I cannot fathom how the council can justify such a large increase in rates. We always seem to be paying more but getting less in return. I would like to know what cot cutting measures the council are taking to minimise the extra financial burden of all rate payers.
31	Object	We are in a cost of living crisis and this increase is above inflation. It is difficult enough for households to afford basic food and electricity in the current climate and these enormous rates will only increase stress on families.
32	Object	I'm against the proposed rate increase. Like any household or business, if funds are insufficient, the solution should be to reduce non-essential spending—not raise taxes.
33	Object	With cost of living crisis everything is too expensive as it is plus we have to always pay for anything regarding the council it's like a double dip
34	Object	Not great with cost of living crisis. Give me bigger red bin, without charging for it. Fix up parent parking at Melville high school. Put my rates to good use.
35	Object	Disgraceful that 8 of think it's a reasonable increase when so many individuals and families are doing it tough at the moment. While the council needs to operate functionally and be sustainable it should not be at the expense of the community.
36	Object	CPI should be applied and cost control measures applied.
37	Object	4.5% is a significant increase that will negatively impact most com residents, us included.
38	Object	I object to the proposed rate increase. The cost of living is already putting pressure on our households this will add to that. Not to mention I am unclear where our current rate contribution is allocated when we are far behind other councils in terms of waste collection and community amenities. Manage your current budget better.
39	Object	Thats a lot to increase for a cost of living crisis. Specifically because a lot of the things supported with this funds do not benefit the community. I think rates should be reduced considering the circumstances not increaded
40	Object	I strongly object to the COM rate increase. This is more than wage increases given to most in one year, more than the current CPI, more than the current interest rate, and just adding to the difficulty many are currently experiencing.
41	Object	500 characters doesn't cut it see the file attached! [Attachment] Rates should not rise! The cost of living crisis is real first of all. Second, we have been requesting the council come and up update Olding park play equipment which is falling apart and they refuse to do it as it's only 8 years old. It is falling apart, rusted, and terrible. We have had to pay extra rates already to get larger bins other councils provide as we have a family of 5. It is also higher than the CPI rise which means my family will be even worse off. So for the council to try and hike rates above that threshold, and lag behind in providing what many believe are normal services is not good enough. No way!

42	Object	You can't increase rates and decrease services and expect the ratepayers to be happy. In general, the city is a great place to live, but you've taken away verge side collections. The current booking system is a nightmare for most of us. Cockburn still do verge collections, have all their bins collected each week (except green), and they get free tip passes. Be more like Cockburn and we won't whinge about you as much online.
43	Object	Outside of increasing wages by 12%, what are you actually doing to improve living in palmyra? You have taken away roadside collection which is increasing illegal dumping. If a park is away from marmion road, they are neglected, there is no shade for children(sorry trees 2ft tall are not good enough) at playgrounds. Playgrounds sit empty in summer as a result. This is a family area and you're taking from palmyra to give to the richer suburbs. Not happy with increase
44	Object	Absurd to have such an increase considering we as rate payers get very little for our money. Booking system for junk collections that are booked out months in advance a bin collection that isn't suitable for fortnightly collections. The cost of living is increasing and wages aren't so how are people able to pay so much more for rates and being one of or the highest in the state definitely not desirable and makes the councillors look very greedy.
45	Object	As a current elector and future ratepayer in the City of Melville, I object to the proposed 4.5% rate increase. Many residents already face higher rates due to property revaluations and rising living costs. The additional increase will cause undue financial strain, especially on low-income households. Interest on overdue payments further burdens those in hardship. Given the City's stabilising finances, I urge the council to reconsider or reduce the increase and explore other funding options.
46	Object	We have not used any of our valet collection opportunities over the past 2 years when the council unilaterally decided to change from verge collection to valet. The new system doesn't suit us at all, yet we still have to pay for it. We are not alone. And you want to increase our rates!!!!! Listen to the community for a change
