Register of Gifts and Contributions to Travel

For the purposes of Local Government (Administration) Regulation 1996 clause 19AF, the Chief Executive Officer of the City of Melville has, as at 23 September 2021, determined that the threshold amount for gifts is \$50.00. The threshold amount applies to employees.

The CEO is required to maintain a register of notifiable gifts. The on-line Gift Register is required to be updated within 10 days of a gift being disclosed.

A relevant person is defined under section 5.74 of the Act as a person who is a Council member or designated employee which includes:

Mayors, Presidents, Council Members, The Chief Executive Officer, Employees with delegated powers or duties under Part 5, Division 4 of the Act, Employees who are members of committees comprising elected members and employees; and other employees as nominated by the local government to be a designated employee.
