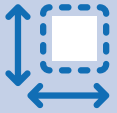




## ABOUT THE CITY OF MELVILLE

# Budget Overview

---





## The City of Melville 2026-2027 Annual Budget has been prepared in accordance with the Local Government Act 1995 and the Local Government (Financial Management) Regulations 1996.

### FINANCIAL OVERVIEW

The City has a strong record of robust and transparent financial planning. In broad terms, the City considers its long-term financial performance and position to be sustainable when planned service and infrastructure levels can be maintained without undue reliance on:

- a very limited number of revenue streams;
- uncontrollable, temporary or highly variable revenue sources;
- large variations in rates increases; or
- unplanned cuts to services.

The City of Melville considers that its community is best served by long-term decisions that reflect the real impacts of rising costs. This approach helps ensure current residents make an equitable contribution to the services they use, while reducing the risk of price shocks, asset failure, or service reductions for future residents.

The 2026-2027 Budget has been achieved without loan borrowings to fund either operating or capital programs, despite significant cost pressures arising from current economic conditions, including employee, materials, contract, and construction costs.

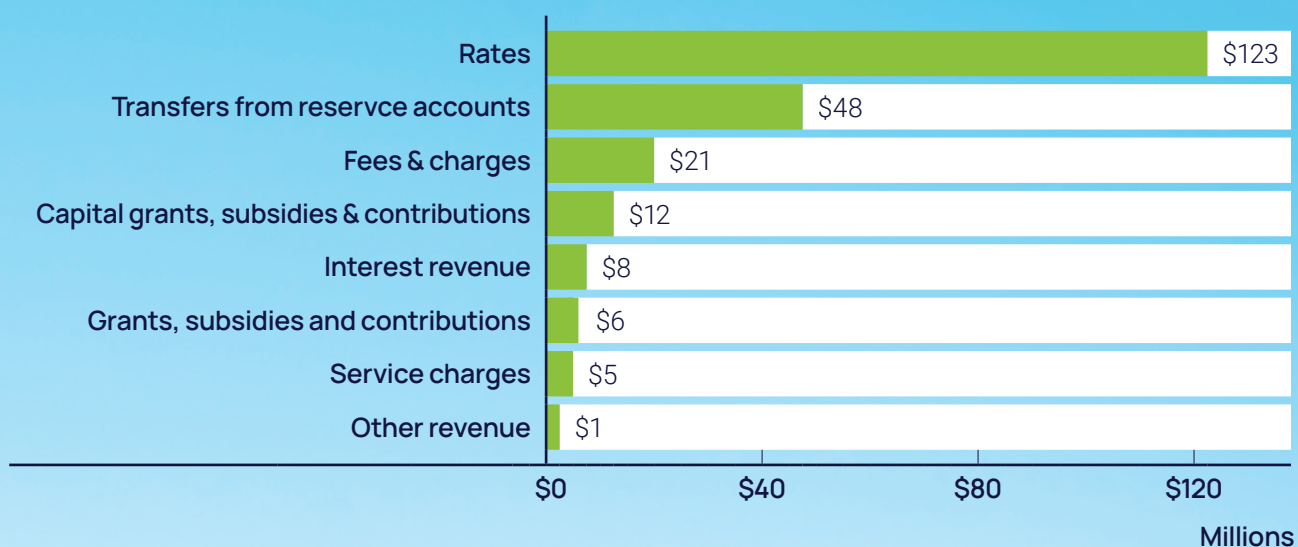
### ANNUAL BUDGET SNAPSHOT

The snapshot below shows that the budget remains balanced while funding significant capital works through reserves and grants rather than new borrowings.

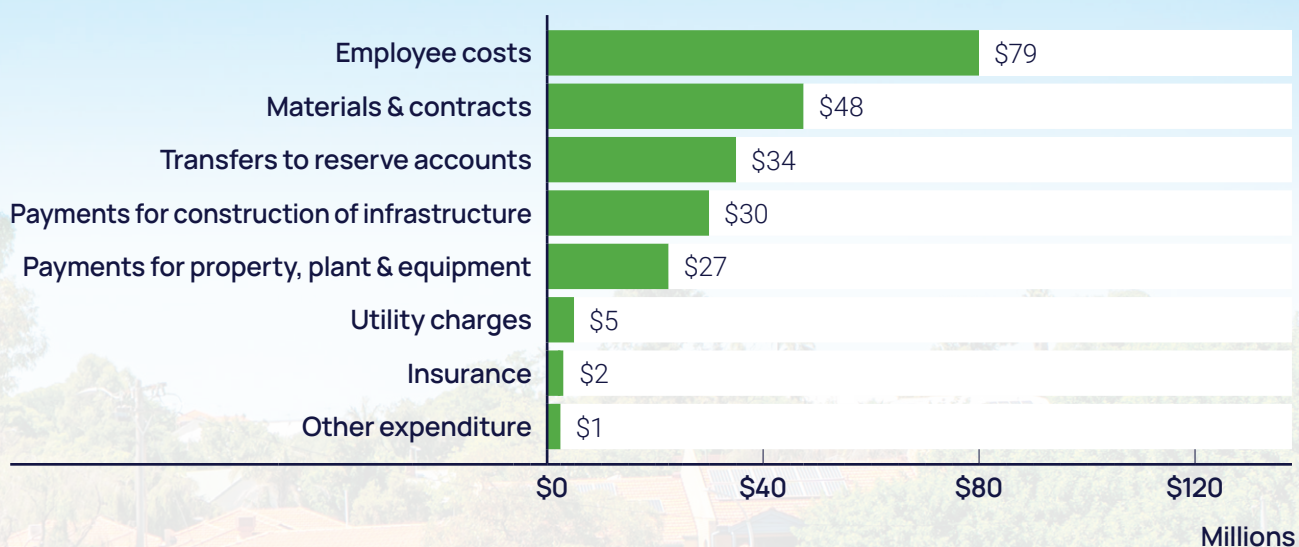

## RATE REVENUE

Total budgeted rate revenue is \$122.6 million. The proposed rates for the 2026-2027 financial year represent an increase of 4.9% in rate revenue for improved land and 8% for unimproved land.

These rates have been set in response to inflationary pressures that have significantly exceeded the City's conservative rates increases in recent years, and to address the long-term impacts and challenges created by that imbalance.

Approximately 78% of rate revenue will be derived from residential rates.

### Operating Revenue other than Rates

Budgeted operating revenue excluding rates income is \$40.7 million.

Nearly 52% of this income is derived from fees and charges (\$21.3 million), generated mainly from services related to Healthy Melville, waste collection, statutory planning and infringements and penalties related to parking. Interest earnings are budgeted at \$8.2 million and \$6.4 million of this will be set aside in the City's reserves. Other income sources include operating grants, service charges, and expense recoveries.

### Operating Expenditure excluding non-cash amounts

Budgeted operating expenditure, excluding non-cash amounts, is \$132.9 million.

Employment costs are budgeted at \$78.5 million and continue to focus on retaining skilled staff, improving service levels, and complying with government mandates relating to occupational superannuation.

The materials and contracts budget of \$47.9 million includes recurrent expenditure required to support the City's service delivery. Inflation has increased the overall cost of doing business, and the budget includes significant cost increases for natural areas and parks maintenance, community safety, plant and vehicle costs, and the City's Digital Strategy.

The operating expenditure budget also includes the cost of cash calls to Western Power for the Willagee/Myaree/Melville underground power project.

### Capital grants, subsidies and contributions

The budget includes \$11.9 million in capital grants for a range of road, building, environmental, parks, and foreshore projects within the 2026-2027 capital works program. This is significantly higher than in previous years due to the City's increased focus on grants advocacy.



## CAPITAL EXPENDITURE

The City of Melville has a significant portfolio of built assets with a replacement value of approximately \$1,945 million. In accordance with the City's Asset Management Policy, priority is given to maintaining and renewing existing assets rather than creating new assets that bring additional maintenance and renewal costs.

The 2026-2027 Budget includes \$56.4 million in capital expenditure. This represents the cash flow requirement for the 2026-2027 year across the full capital works program, including multi-year projects with future cash flow commitments and related budget requirements. The City's capital expenditure is predominantly funded from reserves.

## RESERVE FUNDS & FINANCIAL SUSTAINABILITY

Reserve funds continue to be a key source of funding for the City of Melville. Council has built up a reasonable level of cash-backed, specific-purpose reserves through prudent financial management that considers the needs of current and future generations. Reserve funds are primarily used for the refurbishment, renewal, and development of community infrastructure and other assets.

Over the past few years, the City's reserve balances have gradually declined due to lower amounts being set aside because of affordability pressures and the escalating cost of the capital works program. Further reductions are expected as planned asset renewal, new asset, and upgrade programs continue.

A key focus of the 2026-2027 Budget has been to take remedial action to address this declining trend, with the aim of restoring reserve balances to more sustainable levels over time.

## CONCLUSION

The City's financial principles were recently reviewed by Elected Members and management through a series of corporate planning and budget workshops held up to June 2026. These workshops have informed the 2026-2027 Annual Budget, as well as updates to the Corporate Business Plan and Long-Term Financial Model.

The 2026-2027 Budget has been prepared with a long-term view of the City's ongoing and emerging needs, and those of its residents.

The City of Melville considers that its community is best served by long-term decisions that strengthen resilience and support a positive response to factors affecting the local community and economy, while also recognising the significant rise in construction and infrastructure maintenance costs in recent years.

## **We certify that this is a true and correct copy of the 2026-2027 City of Melville Budget, adopted by Council on 16 June 2026, and used to set the following rates and charges:**

### **Residential Improved**

5.656295 cents in the dollar of the gross rental value applicable to all residential, Department of Housing, strata, duplex and multi-unit improved properties that are zoned for residential purposes.

A minimum rate of \$1,564.90 per assessment will apply.

### **Residential Unimproved**

5.830810 cents in the dollar of the gross rental value applies to all unimproved properties that are zoned for residential purposes.

A minimum rate of \$1,613.53 per assessment will apply.

### **Commercial Improved**

9.480501 cents in the dollar of the gross rental value applicable to commercial, industrial, service stations, hotel/ taverns, strata storage units, hospitals and commercial land.

A minimum rate of \$1,268.77 per assessment will apply.

### **Commercial Unimproved**

9.761589 cents in the dollar of the gross rental value applicable to all unimproved properties that are zoned for commercial purposes.

A minimum rate of \$1,308.20 per assessment will apply.

## **WILLAGEE/MYAREE/MELVILLE UNDERGROUND POWER SCHEME**

In the 2025-2026 annual budget, properties included in the Willagee/Myaree/Melville Underground Power Scheme were charged a network service charge to recover the cost of the underground power network installation work to be undertaken by Western Power in the 2025-2026 financial year. The purpose of this charge was to fund the installation of network infrastructure (e.g. Light poles, underground cabling along the street, and transformers).

In the 2026-2027 financial year, residential properties in the scheme will be charged a connection fee, where required, to connect individual properties to the network infrastructure. The connection fee will vary according to the extent of work required.

For commercial properties, a network service charge will be charged according to the KVA rating required for each property. Commercial properties generally have greater power requirements than residential properties, and the network service charge applied recognises the additional costs of installing infrastructure that is rated to meet those requirements.

## RESIDENTIAL PROPERTIES

Residential properties included in the Willagee/Myaree/Melville Underground Power Scheme shall be charged a connection fee, where required. The connection fee charged is dependent on the extent of work required to connect the property to the network.

## RATING CONCESSIONS

### Rating Concession – Strata Storage Units

A concession is granted to appropriately zoned and used strata-titled storage units of 18m<sup>2</sup> or less. The concession recognises the small physical size of these properties and seeks to address the perceived inequity of applying a standard minimum rate. A concession of \$634 per property applies, resulting in a total concession of \$36,160.

### Rating Concession - Melville Glades Golf Club

A 100% concession from general rates is granted to the Melville Glades Golf Club in recognition of its substantial contribution to the community through the maintenance of vested golf course land. The value of this concession is \$20,295.

## Swimming Pool Inspection Fee

A swimming pool inspection fee of \$65.00 applies for 2026-2027. Swimming pool inspections occur at least once every four years. To spread the cost of inspections and improve administrative efficiency, this amount is collected through four annual payments.

## Property Surveillance and Security Service Charge

A property surveillance and security service charge of \$72.00 per property applies for 2026-2027, including non-rateable and rate-exempt properties.

## Rates Incentives

In 2026-2027, the City of Melville is offering three prizes of \$1,000 in cash, donated by Westpac, and a 12-month LeisureFit membership for ratepayers who pay in full, or pay the first instalment by the due date using any payment method. This incentive is intended to encourage residential and commercial ratepayers to pay on time.

Elected Members and staff are not eligible to win prizes as sole or part owners of any property.

## Administration and Interest Charge for Rates and Service Charges

1. Where a property owner has elected to, and is adhering to, paying rates and service charges through an instalment program, an instalment interest charge of 2% per annum will be imposed in 2026-2027 (2% in 2025-2026). No instalment administration charge will be imposed in 2026-2027 (\$0 in 2025-2026).

**Note:** Section 6.45 of the *Local Government Act 1995* allows a local government to impose an additional charge, above the administrative charge, where rates or service charges are paid by instalments. In effect, this is an interest charge, with a maximum rate of 5.5%, intended to help recover some of the investment revenue that would have been earned if payment had been made in a single lump sum by the first due date. In the absence of an early payment discount, it is considered that imposing this charge will encourage more ratepayers to pay early.

2. An interest charge of 3.5% will be imposed in 2026-2027 (3.5% in 2025-2026) on all rates and service charges including refuse charges, swimming pool inspection fee, property surveillance and security service charge, underground power and streetscape service charges or specified area rates that are not paid by the due date. The interest rate applying to the late payment of the State Government's Emergency Services Levy debts will be at a statutory maximum rate determined by the Department of Fire and Emergency Services.

**Note:** Section 6.51 of the *Local Government Act 1995* allows a local government to impose a maximum interest rate of 11% on amounts owing by those who are not considered to be in financial hardship.

3. A credit card surcharge fee of 0.6% will be imposed in 2026-2027 (0.6% in 2025-2026).



## Interest Charge on Money Owing to Local Government

1. In accordance with section 6.13 of the Local Government Act 1995, a maximum interest rate of 11% may be imposed on all outstanding accounts relating to commercial activities, with interest charged 35 days after the date stated on the account for payment.
2. 50% of the maximum interest charge permitted under the regulations will be imposed on all outstanding accounts relating to community clubs and organisations, with interest charged 60 days after the date stated on the account for payment.
3. Interest charges outlined in items 1 and 2 will not apply where the outstanding account is \$50.00 or less.
4. The Chief Executive Officer has delegated authority to determine which category a particular debt falls within.

**1 BASIS OF PREPARATION**

The annual budget of the City of Melville which is a Class 1 local government is a forward looking document and has been prepared in accordance with the *Local Government Act 1995* and accompanying regulations.

**Local Government Act 1995 requirements**

Section 6.4(2) of the *Local Government Act 1995* read with the *Local Government (Financial Management) Regulations 1996* prescribe that the annual budget be prepared in accordance with the *Local Government Act 1995* and, to the extent that they are not inconsistent with the Act, the Australian Accounting Standards. The Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and Interpretations of the Australian Accounting Standards Board were applied where no inconsistencies exist.

The *Local Government (Financial Management) Regulations 1996* specify that vested land is a right-of-use asset to be measured at cost, and is considered a zero cost concessionary lease. All right-of-use assets under zero cost concessionary leases are measured at zero cost rather than at fair value, except for vested improvements on concessionary land leases such as roads, buildings or other infrastructure which continue to be reported at fair value, as opposed to the vested land which is measured at zero cost. The measurement of vested improvements at fair value is a departure from *AASB 16 Leases* which would have required the City to measure any vested improvements at zero cost.

Accounting policies which have been adopted in the preparation of this annual budget have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the annual budget has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

**The local government reporting entity**

All funds through which the City controls resources to carry on its functions have been included in the financial statements forming part of this annual budget.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies appears at Note 14 to the annual budget.

**2025/26 Forecast balances**

Balances shown in this budget as 2025/26 Actual are estimates as forecast at the time of preparation of the annual budget and are subject to final adjustments.

**Budget comparative figures**

Unless otherwise stated, the budget comparative figures shown in the budget relate to the original budget estimate for the relevant item of disclosure.

**Comparative figures**

Where required, comparative figures have been adjusted to conform with changes in presentation for the current financial year.

**Rounding off figures**

All figures shown in this statement are rounded to the nearest dollar.

**Statement of Cashflows**

Investing and financing transactions that do not require the use of cash or cash equivalents shall be excluded from a statement of cash flows. Such transactions shall be disclosed elsewhere in the financial statements in a way that provides all the relevant information about these investing and financing activities.

**Initial application of accounting standards**

During the budget year, the below revised Australian Accounting Standards and Interpretations are expected to be compiled, become mandatory and be applicable to its operations.

- AASB 2026-1 Amendments to Australian Accounting Standards – Disclosures about Uncertainties in the Financial Statements
- AASB 2024-2 Amendments to Australian Accounting Standards – Classification and Measurement of Financial Instruments
- AASB 2024-3 Amendments to Australian Accounting Standards – Standards – Annual Improvements Volume 11
- AASB 2025-1 Amendments to Australian Accounting Standards – Contracts Referencing Nature-dependent Electricity

It is not expected these standards will have an impact on the annual budget on initial application.

**Critical accounting estimates and judgements**

The preparation of the annual budget in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses.

The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The annual budget is a forward-looking statement and is comprised of management estimates. As with all estimates, the use of different assumptions could lead to material changes in the amounts reported in the annual budget.

The following are estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year and further information on their nature and impact can be found in the relevant note:

- Fair value measurement of assets carried at reportable value including:
  - Property, plant and equipment
  - Infrastructure
  - Expected credit losses on financial assets
  - Impairment losses of non-financial assets
  - Investment property
  - Measurement of employee benefits
  - Measurement of provisions

### (a) Rating Information

The City did not raise specified area rates for the year ended 30th June 2027.

\*Rateable Value at time of adopting budget.

All rateable properties within the district used predominantly for non-rural purposes are rated according to their Gross Rental Valuation (GRV), all other properties are rated according to their Unimproved Valuation (UV).

The general rates detailed for the 2026/27 financial year have been determined by Council on the basis of raising the revenue required to meet the estimated deficiency between the total estimated expenditure proposed in the budget and the estimated revenue to be received from all sources other than general rates and also considering the extent of any increase in rating over the level adopted in the previous year.

The minimum payments have been determined by Council on the basis that all ratepayers must make a reasonable contribution to the cost of local government services/facilities.

### 3. NET CURRENT ASSETS (CONTINUED)

#### (d) MATERIAL ACCOUNTING POLICIES

##### CURRENT AND NON-CURRENT CLASSIFICATION

The asset or liability is classified as current if it is expected to be settled within the next 12 months, being the City's operational cycle. In the case of liabilities where the City does not have the right to defer settlement beyond 12 months, such as vested long service leave, the liability is classified as current even if not expected to be settled within the next 12 months. Inventories held for trading are classified as current or non-current based on the City's intentions to release for sale.

##### TRADE AND OTHER PAYABLES

Trade and other payables represent liabilities for goods and services provided to the City prior to the end of the financial year that are unpaid and arise when the City becomes obliged to make future payments in respect of the purchase of these goods and services. The amounts are unsecured, are recognised as a current liability and are normally paid within 30 days of recognition. The carrying amounts of trade and other payables are considered to be the same as their fair values, due to their short-term nature.

##### PREPAID RATES

Prepaid rates are, until the taxable event has occurred (start of the next financial year), refundable at the request of the ratepayer. Rates received in advance are initially recognised as a financial liability. When the taxable event occurs, the financial liability is extinguished and the City recognises revenue for the prepaid rates that have not been refunded.

##### INVENTORIES

###### General

Inventories are measured at the lower of cost and net realisable value.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

##### INVENTORY - LAND HELD FOR RESALE

Land held for development and sale is valued at the lower of cost and net realisable value. Cost includes the cost of acquisition, development, borrowing costs and holding costs until completion of development. Finance costs and holding charges incurred after development is completed are expensed.

Gains and losses are recognised in profit or loss at the time of signing an unconditional contract of sale if significant risks and rewards, and effective control over the land, are passed on to the buyer at this point.

Inventory - land held for resale is classified as current except where it is held as non-current based on the City's intentions to release for sale.

##### SUPERANNUATION

The City contributes to a number of superannuation funds on behalf of employees. All funds to which the City contributes are defined contribution plans.

##### GOODS AND SERVICES TAX (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows.

##### CONTRACT LIABILITIES

Contract liabilities represent the City's obligation to transfer goods or services to a customer for which the City has received consideration from the customer.

Contract liabilities represent obligations which are not yet satisfied. Contract liabilities are recognised as revenue when the performance obligations in the contract are satisfied.

##### TRADE AND OTHER RECEIVABLES

Trade and other receivables include amounts due from ratepayers for unpaid rates and service charges and other amounts due from third parties for grants, contributions, reimbursements, and goods sold and services performed in the ordinary course of business.

Trade and other receivables are recognised initially at the amount of consideration that is unconditional, unless they contain significant financing components, when they are recognised at fair value.

Trade receivables are held with the objective to collect the contractual cashflows and therefore the City measures them subsequently at amortised cost using the effective interest rate method.

Due to the short term nature of current receivables, their carrying amount is considered to be the same as their fair value. Non-current receivables are indexed to inflation, any difference between the face value and fair value is considered immaterial.

The City applies the AASB 9 simplified approach to measuring expected credit losses using a lifetime expected loss allowance for all trade receivables. To measure the expected credit losses, rates receivable are separated from other trade receivables due to the difference in payment terms and security for rates receivable.

##### PROVISIONS

Provisions are recognised when the City has a present legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

##### EMPLOYEE BENEFITS

###### Short-term employee benefits

Provision is made for the City's obligations for short-term employee benefits. Short term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The City's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the determination of the net current asset position.

The City's obligations for employees' annual leave and long service leave entitlements are recognised as provisions in the determination of the net current asset position.

###### Other long-term employee benefits

Long-term employee benefits provisions are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur.

The City's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the City does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

**MATERIAL ACCOUNTING POLICES**

**CASH AND CASH EQUIVALENTS**

Cash and cash equivalents include cash on hand, cash at bank, deposits available on demand with banks, other short term highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Term deposits are presented as cash equivalents if they have a maturity of three months or less from the date of acquisition and are repayable with 24 hours notice with no loss of interest.

Bank overdrafts are shown as short term borrowings in current liabilities in Note 3 - Net Current Assets.

**FINANCIAL ASSETS AT AMORTISED COST**

The City classifies financial assets at amortised cost if both of the following criteria are met:

- the asset is held within a business model whose objective is to collect the contractual cashflows, and
- the contractual terms give rise to cash flows that are solely payments of principal and interest.

Interest received is presented under cashflows from operating activities in the Statement of Cash Flows where it is earned from financial assets that are held for cash management purposes.

50% of the maximum interest charge permitted under the regulations may be imposed on all outstanding accounts in respect to community clubs and organisations with such interest being charged sixty days after the date which is stated on the account for payment.

Interest charges outlined above will not apply where the account outstanding is \$50.00 or less.

The Chief Executive Officer has been granted delegated authority to determine which category a particular debt falls within.

**12. TRADING UNDERTAKINGS AND MAJOR TRADING UNDERTAKINGS**

**Melville City Centre Land Exchange, Booragoon**

The Melville City Centre Structure Plan was approved in 2015. The Plan responded to a proposal by the owners of the Garden City Shopping Centre (Westfield Booragoon) to expand the existing centre. The Structure Plan requires the creation of a vibrant "High Street" generally in the area between the shopping centre and the City of Melville Administration Centre. Achievement of the High Street would be enhanced through an adjustment of the boundary between the City's land and the shopping centre site. A conditional "like for like" land swap had been agreed between the City and AMP Capital Funds Management to achieve a rationalisation of this boundary. The land exchange agreement was approved by Council and executed in 2015. The City of Melville's agreements with AMP Capital Funds Management expired in July 2020 when the Sunset Date lapsed. As a result that agreement has come to an end.

Late in 2019, AMP Capital Funds Management sold 50% of its interest in Westfield Booragoon to Scentre Custodian Pty Ltd (Westfield) including management and development rights. Due to the restructured ownership of the Westfield Booragoon, Scentre Group has revised the redevelopment scheme and High Street. As a result the location of the High Street has changed slightly but the need for the land exchange was still apparent. In March 2021 AMP Capital Funds Management sold its remaining 50% interest in Westfield Booragoon to Dexu Wholesale Property Limited.

Council approved the advertising of the proposed new land exchange under Section 3.58 of the Local Government Act 1995 in December 2020. Public submissions were presented after the close of the Public Notice period and Council approved the preparation of the land exchange agreement between the City of Melville and Scentre Custodians Pty Ltd/ Dexu Wholesale Property Limited. Council approved the Agreement for Exchange of Land: Melville City Centre at the February 2022 Ordinary Meeting of Council. The Agreement was executed late in 2023.

Scentre Group lodged its Development Application with the State Development Assessment Unit (SDAU) in September 2021 for the redevelopment of Westfield Booragoon Shopping Centre and creation of the High Street. The application was approved by the SDAU in February 2023. No significant works have commenced as of yet. However, the first condition of precedent in the Land Exchange Agreement (LEA) has been met by Scentre Group & Dexu.

In May 2025 Scentre group sought a further extension to their current DA which was approved by the SDAU on 15th May 2025, with a determination that substantial commencement must now occur by May 2029.

Therefore, the agreement and all conditions of the LEA remain on foot as at the 30th June 2026.



## 12. TRADING UNDERTAKINGS AND MAJOR TRADING UNDERTAKINGS (CONTINUED)

### **Carawatha “Gallery” Residential Development Project, Willagee**

As identified as part of the Land Asset Strategy review and Council decision in December 2013, the City undertook a Request for Proposal (RFP) process in April 2015 to explore options for the potential redevelopment of a portion of the former Carawatha Primary School site in Willagee, which the City acquired from the State Government in June 2006. Subsequently a proponent (Satterley Property Group) was selected from the RFP assessment process and the City has finalised the redevelopment concepts, development model and agreements which will see Satterley Property Group as Project Manager, Satterley Carawatha Pty Ltd as Developer and the City of Melville as Owner. The appointment of the proponent followed the relevant provisions (Section 3.59) of the Local Government Act 1995 which dealt with the Major Land Transactions. The City of Melville entered into a Development Agreement with Satterley Carawatha Pty Ltd and Project Management, Marketing and Sales Agreement with Satterley Property Group.

The project received subdivision approval from the Western Australian Planning Commission in March 2019. Satterley Property Group commenced the civil subdivision works in August 2019 with Practical Completion in March 2020. New Titles were issued for all the subdivided lots in May 2020 and these Titles remain in the name of the City of Melville (Owner) until sold or redeveloped and sold. The project includes 23 Cottage Lots, 16 Terrace Homes and 4 Apartments complex totalling 98 Apartments.

All 23 Cottage lots have now sold and settled and the project manager (Satterley) tendered to the building industry for the construction of the 16 Terrace Homes and appointed and contracted Inspired Homes to construction the homes in line. Construction commenced in late 2021 with completion and settlement expected early 2024 as per the revised project programme. The first stage of the apartment constructions will occur once the project's management committee has determined that it is feasible in-light of the inflationary climate in the Economy and Construction Industry.

All 18 town houses have been completed and settled.

An extension was granted by the SDAU to substantially commence by 17th November 2028.

### **Melville District Centre - Stock Rd Palmyra Strategic Site Ground Lease Redevelopment Proposal**

Council approved the ground lease redevelopment proposal by Hall & Prior Aged Care Group in December 2018. The ground lease development agreements were approved by Council in December 2020 and signed and executed. Hall & Prior are in the process of satisfying their conditions under the Agreement for Lease and lodged its Development Application on the 20 December 2022 which will be determined by the SDAU. Site handover is planned for not until the end of 2024 with construction and redevelopment of the site into a \$60M+ integrated aged care and community facility to commence shortly after by Hall & Prior. The construction is expected to take 2 years with the ground lease income stream to commence flowing to the City at that time.

The ground lease term including options is up to 90 years. The commencing annual lease value is \$350,000 p.a. resulting in an estimated cumulative notional ground lease value of approximately \$112 Million.

Construction is expected to commence by late 2027.

### 13. JOINT ARRANGEMENTS

#### **Carawatha “Gallery” Residential Development Project, Willagee**

The City is an equal participant in the Carawatha Residential Redevelopment Project in Willagee with the Satterley Property Group via its Development Agreement with Satterley Carawatha Pty Ltd. The City’s financial interest is represented by contributing the value of the land at market value to the project whilst Satterley Property Group contribute working capital to the project to fund development via payment of a Participation Fee which equates to the market value of land contributed by the City. In turn both participants will be called upon to contribute additional proportionate working capital to fund the building construction phase of the project. The City’s capital is to be funded from the Land and Property Reserve with a maximum limit of \$8M approved in the Long Term Financial Plan. The City and Satterley Carawatha Pty Ltd will receive profit distributions in equal proportion during and at the end of the redevelopment project together with a return of all capital and land value contributed.

#### **MATERIAL ACCOUNTING POLICIES**

##### **Investments in associates**

An associate is an entity over which the City has significant influence. Significant influence is the power to participate in the financial operating policy decisions of that entity but is not control or joint control of those policies. Investments in associates are accounted for in the financial statements by applying the equity method of accounting, whereby the investment is initially recognised at cost and adjusted thereafter for the post-acquisition change in the City’s share of net assets of the associate. In addition, the City’s share of the profit or loss of the associate is included in the City’s profit or loss. recognised.

The carrying amount of the investment includes, where applicable, goodwill relating to the associate. Any discount on acquisition, whereby the City’s share of the net fair value of the associate exceeds the cost of investment, is recognised in profit or loss in the period in which the investment is acquired.

##### **Investments in associates (continued)**

Profits and losses resulting from transactions between the City and the associate are eliminated to the extent of the City’s interest in the associate. When the City’s share of losses in an associate equals or exceeds its interest in the associate, the City discontinues recognising its share of further losses unless it has incurred legal or constructive obligations or made payments on behalf of the associate. When the associate subsequently makes profits, the City will resume recognising its share of those profits once its share of the profits equals the share of the losses not recognised.

##### **Interest in Joint Arrangements**

Joint arrangements represent the contractual sharing of control between parties in a business venture where unanimous decisions about relevant activities are required. Separate joint venture entities providing joint venturers with an interest to net assets are classified as a joint venture and accounted for using the equity method. Joint venture operations represent arrangements whereby joint operators maintain direct interests in each asset and exposure to each liability of the arrangement. The City’s interests in the assets, liabilities, revenue and expenses of joint operations are included in the respective line items of the Financial Statements.

### 14. TRUST FUNDS

Trust funds previously held in trust have been transferred to a reserve account under section 153 and Local Government Act 1995 section 6.11 for the purposes set out in subsection (2)(a) to (d). There is no balance in the trust fund.

**(a) Revenue and Expenditure Classification**

**REVENUES**

**RATES**

All rates levied under the *Local Government Act 1995*. Includes general, differential, specific area rates, minimum payment, interim rates, back rates, ex-gratia rates, less discounts offered.  
Exclude administration fees, interest on instalments, interest on arrears, service charges and sewerage rates.

**GRANTS, SUBSIDIES AND CONTRIBUTIONS**

All amounts received as grants, subsidies and contributions that are not capital grants.

**CAPITAL GRANTS, SUBSIDIES AND CONTRIBUTIONS**

Amounts received specifically for the acquisition, construction of new or the upgrading of non-current assets paid to a local government, irrespective of whether these amounts are received as capital grants, subsidies, contributions or donations.

**REVENUE FROM CONTRACTS WITH CUSTOMERS**

Revenue from contracts with customers is recognised when the local government satisfies its performance obligations under the contract.

**FEES AND CHARGES**

Revenues (other than service charges) from the use of facilities and charges made for local government services, sewerage rates, rentals, hire charges, fee for service, photocopying charges, licences, sale of goods or information, fines, penalties and administration fees.  
Local governments may wish to disclose more detail such as rubbish collection fees, rental of property, fines and penalties, other fees and charges.

**SERVICE CHARGES**

Service charges imposed under *Division 6 of Part 6 of the Local Government Act 1995*. Regulation 54 of the *Local Government (Financial Management) Regulations 1996* identifies the charges which can be raised. These are television and radio broadcasting, underground electricity and neighbourhood surveillance services and water.  
Exclude rubbish removal charges which should not be classified as a service charge. Interest and other items of a similar nature received from bank and investment accounts, interest on rate instalments, interest on rate arrears and interest on debtors.

**INTEREST REVENUE**

**PROFIT ON ASSET DISPOSAL**

**EXPENSES**

**EMPLOYEE COSTS**

All costs associated with the employment of person such as salaries, wages, allowances, benefits such as vehicle and housing, superannuation, employment expenses, removal expenses, relocation expenses, worker's compensation insurance, training costs, conferences, safety expenses, medical examinations, fringe benefit tax, etc.

Note: *AASB 119 Employee Benefits* provides a definition of employee benefits which should be considered.

**MATERIALS AND CONTRACTS**

All expenditures on materials, supplies and contracts not classified under other headings. These include supply of goods and materials, legal expenses, consultancy, maintenance agreements, communication expenses (such as telephone and internet charges), advertising expenses, membership, periodicals, publications, hire expenses, rental, leases, postage and freight etc.

Local governments may wish to disclose more detail such as contract services, consultancy, information technology and rental or lease expenditures.

**UTILITIES (GAS, ELECTRICITY, WATER)**

Expenditures made to the respective agencies for the provision of power, gas or water.

Exclude expenditures incurred for the reinstatement of roadwork on behalf of these agencies.

**INSURANCE**

All insurance other than worker's compensation and health benefit insurance included as a cost of employment.

**LOSS ON ASSET DISPOSAL**

Loss on the disposal of fixed assets.

**DEPRECIATION ON NON-CURRENT ASSETS**

Depreciation and amortisation expenses raised on all classes of assets.

**FINANCE COSTS**

Interest and other costs of finance paid, including costs of finance for loan debentures, overdraft accommodation and refinancing expenses.

**OTHER EXPENDITURE**

Statutory fees, taxes, provision for bad debts, member's fees or levies including DFES levy and State taxes. Donations and subsidies made to community groups.

**Housing**

To provide and maintain housing.

**Community amenities**

To provide services required by the community.

**Recreation and culture**

To establish and effectively manage infrastructure and resources which will help the social wellbeing of the community.
