- Overflow parking is permitted to take place in the highlighted area on the attached map.
- Marshalls/Traffic warden should be appointed to assist with directing traffic to parking.
- Please make contact with the council if the club require a gate key to allow access to this parking area.
- Structures (including bouncy castles) are not permitted to be set up on the playing surfaces. These must be set up on the perimeter of the reserve.
- A copy of the bouncy castle's current Certificate of Currency must be supplied to the City no later than one working day before the event/function.
- Weights must be used to secure any structures (including bouncy castles). Stakes/pegs are not permitted to be used.
- Please note this booking is only approving the use of the reserve. If you
  require access to the amenities located at the reserve you will need to liaise
  with the Troy Park Sporting Association.
