The Contract period is for an initial term of one (2) years with three (3) additional 12 month option periods which will be exercised at the sole discretion of the City. The City will appoint one Contractor for the provision of the services under the Contract. Please note the City does not guarantee the amount of work which will be required as part of this Contract.

The City reserves the right to engage a Contractor outside of this Contract for works not specifically covered under this Contract. The City also reserves the right to engage a Contractor outside of this Contract for works unique to a Contractor.

The services under the proposed Contract shall include Emergency Works, High Urgency works, Medium Urgency works, Low Urgency works and planned works. From time to time, services may be required out of normal working hours and on short notice, refer to item 2.6.

The Contract excludes Priority 5 (Planned) works over \$5,000.00. Quoted works over \$5,000.00 will be competitively quoted as per the City's Purchasing and Procurement Policy. The Contractor that is awarded this Contract will be eligible to quote for works over \$5,000.00 however the City reserves the right to choose any Contractors for quoted works as deemed appropriate by the Contract Manager.

The City reserves the right to engage a contractor outside of this Contract for plumbing systems unique to a specific contractor/ supplier
