<b>Tender Description:</b> <i>Reg 17(2)(a)</i>	<p>The City of Melville ("City"), is seeking a suitably qualified and experienced Contractor to undertake the construction of a new LED floodlighting system to Bill Ellson Reserve located at 1 Mandala Crescent, Bateman. The reserve consists of a large oval for outdoor sport such as cricket, football and hockey. Bateman Primary School also use the oval for school sport events and activities.</p> <p>The construction works consist of the supply and installation of 3 x 28m and 1 x 35m LED lighting towers to the oval. Supply and installation of associated electrical services for the new lighting installation connected to the existing electrical supply. The installation is required to supply a minimum of 50 lux capacity and future capability to increase to 100 lux in the future.</p> <p>The electrical services installation will require directional drilling to minimise the impact on the reserve sports surface. The new lights will need to be controlled by the Halytech system and integrated into the existing Halytech Illuminator central portal. Setup of this system forms part of the scope of works and the City will provide the information to do so.</p>
