The City currently has a fleet of 480 vehicles, plant and equipment which includes:</p> <ul style="list-style-type: none"> • 86 passenger vehicles including utilities • 21 waste trucks • Assorted trucks, sweeper trucks, compactors, trailers, front end loaders, ride on mowers and general equipment. <p>The City’s fleet is subject to change over time and the City does not guarantee the amount of work which will be required as part of this Contract.</p> <p>The Services will generally be carried out at the City’s Operation Centre (Bramanti Road in Murdoch). In the case of a vehicle breakdown requiring auto electrical works, the Contractor may be requested to attend to a vehicle anywhere within the City’s boundaries.</p> <p>The Contract period is for an initial term of two years with two additional 24 month option periods which will be exercised at the sole discretion of the City.</p> <p>The Services shall include emergency works, urgent works, non-urgent works and planned works. From time to time, Services may be required out of normal working hours and on short notice.</p> <p>The City reserves the right to engage a contractor outside of this Contract for auto electrical systems unique to a specific contractor/supplier.</p> <p>This Contract excludes auto electrical services provided as part of the supply of a good (e.g. installation of GPS units).</p>
