	In an agreement with the land owners to the east of the site, the property boundary is moving so that the existing chiller compound will no longer be on the City of Melville's site. There is therefore a critical requirement to have the works complete and operational prior to Westfield taking possession of the land. The City is currently awaiting a 12-month notification from Westfield to confirm this date.
