Tender Description: Reg 17(2)(a)	<p>The City of Melville (City) is seeking a suitably qualified and experienced Contractor to undertake the supply of cleaning services for toilets and change rooms located on parks and reserves throughout the City of Melville. A Summary of buildings is included in Appendix A – Building Schedule.</p> <p>The Contract period is for an initial term of two (2) years with two (2) additional 24 month option periods which will be exercised at the sole discretion of the City. The City will appoint one Contractor for the provision of the services under the Contract. Please note the City does not guarantee the amount of work which will be required as part of this Contract.</p> <p>The services under the proposed Contract shall include Emergency Works, High Urgency works, Medium Urgency works, Low Urgency works and Planned works. From time to time, services may be required out of normal working hours and on short notice, refer to item 1.2.12.</p> <p>The contractor is to be aware that this contract is performance based and its intent is to guarantee cleaning of the absolute highest quality. All daily, weekly, monthly and periodical cleaning must be carried out thoroughly. It is expected that the cleaning staff will be diligent in carrying out their duties in accordance with this specification.</p> <p>In the event the Contractor is unable to provide the Services required under the Contract, the City reserves the right, to engage a Contractor outside of the Contract to carry out the works.</p> <p>The City reserves the right to engage a Contractor outside of this Contract for works not specifically covered under this Contract or for works that form part of a Minor or Major Project. The City also reserves the right to engage a Contractor outside of this Contract for works unique to a Contractor.</p> <p>The City reserves the right to add and remove buildings and fixtures from the list provided in Appendix A – Toilet Cleaning Schedule. Due to the City's Upgrade and Renewal programs as well as unforeseen Operational requirements, the facilities listed are not guaranteed to be included in the specification for the duration of the contract.</p>
