### POLICY OBJECTIVES

To provide financial assistance in response to disaster appeals so as to help alleviate the impacts of disasters.

### POLICY SCOPE

Disaster appeals launched by bona fide Australian based disaster relief agencies to help alleviate the impact of State, National and, if approved by Council, International disasters as further detailed below.

### POLICY STATEMENT

Funding to support disasters is restricted to the total allocation which is determined annually during the budget process, with a maximum amount (unless otherwise determined by Council) of five thousand dollars (\$5,000) to any one incident/appeal.

The guidelines for funding are as follows:
